PAYETTE COUNTY	March ⁴ 5 at 10:00 a.m.; Sept. ² 3 at 10:00 a.m.
WASHINGTON COUNTY	March ⁷ 1 at 10:00 a.m.; Sept. ⁶ 1 at 10:00 a.m.

For the Magistrate Division courts of the Third Judicial
District, the terms in each county will coincide in duration and
in point of time with the terms of court in the District Court.

PAYETTE COUNTY	Each first Friday at 10:00 a.m. Each third Friday at 1:30 p.m.
WASHINGTON COUNTY	Each first Monday at 10:00 a.m. Each third Friday at 10:00 a.m.


It is further ordered that the Law and Motion Days of the Magistrate Division of the District Court in the respective counties be and they are hereby fixed as follows:

ADAMS COUNTY	Each first Friday at 9:30 a.m.
CANYON COUNTY	Each Wednesday at 9:30 a.m.
GEM COUNTY	Each first Monday at 9:30 a.m. Each third Monday at 9:30 a.m.
OWYHEE COUNTY	Each fourth Thursday at 10:00 a.m.
PAYETTE COUNTY	Each second Tuesday at 9:30 a.m. Each fourth Tuesday at 9:30 a.m.
WASHINGTON COUNTY	Each first Wednesday at 9:30 a.m. Each third Wednesday at 9:30 a.m.


