CANYON COUNTY	March 4 at 10:00 AM; Sept. 2 at 10:00 AM.
GEM COUNTY	March 28 at 10:00 AM; Sept. 26 at 10:00 AM.
OWYHEE COUNTY	March 11 at 10:00 AM; Sept. 9 at 10:00 AM.
PAYETTE COUNTY	March 4 at 10:00 AM; Sept. 2 at 10:00 AM;
WASHINGTON COUNTY	March 7 at 10:00 AM; Sept. 6 at 10:00 AM.

It is further Ordered that the Law and Motion Days of District Court in the respective counties be and they are hereby fixed as follows:

ADAMS COUNTY	Each first Tuesday at 10:00 AM.
CANYON COUNTY	Each Friday at 10:00 AM.
GEM COUNTY	Each second Monday at 10:00 AM. Each fourth Monday at 10:00 AM.
OWYHEE COUNTY	Each second Friday at 10:00 AM.
PAYETTE COUNTY	Each first Friday at 10:00 AM. Each third Friday at 1:30 PM.
WASHINGTON COUNTY	Each first Monday at 10:00 AM. Each third Friday at 10:00 AM.

For the Magistrate Division courts of the Third Judicial District, the terms in each county will coincide in duration with the terms of court in the District Court, as follows:

ADAMS COUNTY March 4 at 9:30 AM; Sept. 2 at 9:30 AM.  
 CANYON COUNTY March 9 at 10:00 AM; Sept. 14 at 10:00 AM.  
 GEM COUNTY April 4 at 9:30 AM; October 3 at 9:30 AM;  
 OWYHEE COUNTY March 24 at 10:00 AM; Sept. 22 at 10:00 AM.  
 PAYETTE COUNTY March 8 at 9:30 AM; Sept. 13 at 9:30 AM.  
 WASHINGTON COUNTY March 2 at 9:30 AM; Sept. 7 at 9:30 AM.

It is further Ordered that the Law and Motion Days of the Magistrate Division of the District Court in the respective counties be and they are hereby fixed as follows:

ADAMS COUNTY Each first Friday at 9:30 AM.  
 CANYON COUNTY Each Wednesday at 9:30 AM.  
 GEM COUNTY Each first Monday at 9:30 AM.  
 Each third Monday at 9:30 AM.  
 OWYHEE COUNTY Each fourth Thursday at 10:00 AM.  
 PAYETTE COUNTY Each second Tuesday at 9:30 AM.  
 Each fourth Tuesday at 9:30 AM.  
 WASHINGTON COUNTY Each first Wednesday at 9:30 AM.  
 Each third Wednesday at 9:30 AM.

It is further ordered that criminal cases may be called for trial setting on any motion day, with the defendant being personally present. All civil cases may be called for trial and/or pretrial setting by filing and serving a request for setting as provided by the Third District Court Rules.

It is further ordered that this order be filed and entered of record by the Clerk of said Court in each County of said District and that the same be published two consecutive weeks in a newspaper in said District.
