
WHEREAS, this Court previously entered Administrative Order 2007-2 on February 9, 2007 that governs the procedures for the processing of misdemeanor citations and arraignments; and

WHEREAS, Section 31-3201B, Idaho Code, has been amended effective July 1, 2012 that increases the Peace Officers Standards and Training fee from \$10.00 to \$15.00 for each conviction of a misdemeanor count; and

WHEREAS, a new statute, Section 31-3204, Idaho Code, Victim Notification Fee has been enacted effective July 1, 2012 that establishes a \$10 victim notification fee for each conviction of a misdemeanor count,

NOW, THEREFORE, IT IS HEREBY ORDERED that the amended list of payable offense as reflected on Attachment A to this order is adopted for offenses committed on or after July 1, 2012.
