Washington County	September 7, 1977 at 9:30 AM


Also effective July 1, 1977, Law and Motion Days for the Magistrate Division of the District Court in the respective counties shall be as follows:

Owyhee County	Fourth Thursday of each month at 10:00 AM
Payette County	Second Tuesday of each month at 9:30 AM Fourth Tuesday of each month at 9:30 AM
Washington County	First Wednesday of each month at 9:30 AM Third Wednesday of each month at 9:30 AM

IT IS FURTHER ORDERED that criminal cases may be called for trial setting on any motion day, with the defendant being personally present. All civil cases may be called for trial and/or pre-trial setting by filing and serving a request for setting as provided by the Third District Court Rules.


