in point of time with the terms of court in the district court.


It is further ordered that the Law and Motion Days of

 Each third Friday at 10:00 a.m.



It is further ordered that this order be filed and entered of record by the Clerk of said Court in each County of said District and that the same be published two consecutive weeks in a newspaper published in said District.


