Under and by virtue of the authority vested in the undersigned by the Statutes of the State of Idaho we do hereby fix the terms of court for the Third Judicial District of the State of Idaho for the year 1974 to commence and be held in the various counties of said District as follows:

ADAMS COUNTY	March 5 at 10:00 a.m.; Sept. 3 at 10:00 a.m.
CANYON COUNTY	March 1 at 10:00 a.m.; Sept. 6 at 10:00 a.m.
GEM COUNTY	March 25 at 10:00 a.m.; Sept. 23 at 10:00 a.m.
OWYHEE COUNTY	March 8 at 10:00 a.m.; Sept. 13 at 10:00 a.m.
PAYETTE COUNTY	March 1 at 10:00 a.m.; Sept. 6 at 10:00 a.m.
WASHINGTON COUNTY	March 4 at 10:00 a.m.; Sept. ^{W.D.} 4 at 10:00 a.m.

For the Magistrates Division courts of the Third Judicial District, the terms in each county will coincide in duration and in point of time with the terms of court in the district court.

It is further ordered that the Law and Motion Days of District Court in the respective counties be and they are hereby fixed as follows:

ADAMS COUNTY	Each first Tuesday at 10:00 a.m.
CANYON COUNTY	Each Friday at 10:00 a.m.
GEM COUNTY	Each second Monday at 10:00 a.m. Each fourth Monday at 10:00 a.m.
OWYHEE COUNTY	Each second Friday at 10:00 a.m.
PAYETTE COUNTY	Each first Friday at 10:00 a.m. Each third Friday at 1:30 p.m.
WASHINGTON COUNTY	Each first Monday at 10:00 a.m. Each third Friday at 10:00 a.m.

It is further ordered that criminal cases may be called for trial setting on any motion day, with the defendant being personally present. All civil cases may be called for trial and/or pretrial setting by filing and serving a request for setting as provided by the Third District Court Rules.

It is further ordered that this order be filed and entered of record by the Clerk of said Court in each County of said District and that the same be published two consecutive weeks in a newspaper published in said District.
