Whereas, Idaho Code section 1-2918(3) authorizes the undersigned to order the sheriffs and clerks of all counties in this judicial district not to accept the posting of any new bail bonds from a surety insurance company that fails to pay the amount of any bail forfeited within the time required by statute until such time as the amount of bail forfeited has been paid; and


