WHEREAS, pursuant to the attached ORDER of the Idaho Supreme Court, dated August 21, 2018. "Administrative Judges may authorize and assign a Problem Solving Court calendar to any of the Magistrate Judges of their, District;" and,

WHEREAS, by Order of the Idaho Supreme Court Senior Magistrate Judge William B. Dillon has been assigned to the Third Judicial District as a senior magistrate judge; and,

WHEREAS, pursuant to I.C. section 1-2221(4), a "senior judge assigned as provided in this section has all the judicial powers and duties, while serving under the assignment, of a regularly qualified judge of the court to which the senior judge is assigned;"

IT IS HEREBY ORDERED that Senior Magistrate Judge William B. Dillon is assigned to preside over matters coming before the Canyon County Veterans Treatment Court, when needed, until further order of the Administrative District Judge.

Pursuant to I.C.A.R. 7(b) and 5.1(b)(1), Administrative District Judges have requested the Supreme Court authorize the assignment of additional cases to Magistrate Judges of their respective District, specifically: to preside over all aspects of felony cases which are transferred to the District's Problem Solving Courts.

The Court, having considered the request, and good cause appearing:

IT IS HEREBY ORDERED that Administrative District Judges may authorize and assign a Problem Solving Court calendar to any of the Magistrate Judges of their District, however, upon a participant's removal from that court, the matter will be referred back to the original District Judge;

IT IS FURTHER ORDERED that each Magistrate Judge so assigned shall, within ten (10) days of the specific case being assigned to the designated magistrate, notify the parties to the action of his or her authority granted by this order. Any objection to the propriety of assignment of a magistrate judge per this order shall be waived unless made within seven (7) days of the service of such notice; and

IT IS FURTHER ORDERED that this authorization of expansion of assignments shall continue from the date of this order until otherwise provided by an order of this Court.
